



Are you registered to vote in the state of California?





Have you already voted in the 2020 general election? (Election day is November 3rd, but it is possible to have already participated via early voting locations or mail in ballots).







Taxes such properties based on current market value, instead of purchase price. Fiscal impact: increased property taxes on commercial properties worth more than \$3 million providing \$6.5 billion to \$11.5 billion in new funding to local governments and schools.












Prop 22 Already Voted: Cross-Tabs



Prop 22 Already Voted: Heat Maps








If we asked you to express how likely you are to vote in a percentage in which 0% means you are certain you will not vote and 100% means you are certain you will vote, which would best describe you?





How will you cast your ballot this year?














Prop 22 Likely Voters: Cross-Tabs






In your opinion, should app-based drivers for companies like Uber, DoorDash, Lyft, Postmates, Instacart and others be independent contractors or employees of the companies?




Would it be better for the drivers if they were considered independent contractors or employees?




Would it be better for companies like Uber, Lyft, DoorDash, Instacart, Postmates, and others if drivers are considered independent contractors or employees?




What do you think drivers for companies like Uber, Lyft, DoorDash, Postmates, Instacart, and others prefer?




How important to you is the issue of whether app-based drivers are treated as independent contractors or employees?



















Do you live in an urban, suburban, or rural area?




Which of the following best describes your current relationship status?
